

2024 Claims Male General Terms and Conditions

- The Claims Male entries are NOT part of the ILR Gathering Sale
- All Claims Male Entries must be fully registered with ILR
- The seller of the Claims Male entry will be responsible for setting the claim price on the entry/application form for promotion
- This price and animal information will be listed on the show website (<u>www.ilrshows.com</u>) once all paperwork is provided by the seller
- If the seller chooses to use the term "Please Inquire" instead of promoting an amount, they must give the desired claim amount to the sale committee for tracking purposes
- If the seller decides to adjust their claim amount after promotions have begun and they want this promoted, they must make the committee aware IN WRITING and understand that this change could take up to 3 business days to implement on the website from the date/time received.
- The seller and the potential buyer are responsible for their own negotiations including, but not limited to, the transfer of ownership with ILR, payment arrangements and transportation arrangements.
- No Claim Male payment, other than the class fee, will be handled by ILR or the Gathering Committee
- ILR, ILR-SD and the Gathering Committee assume NO responsibility, legal or otherwise, in regard to any negotiations, terms, payment or the sale contract
- There is a class fee for each Claims Male entry of \$50 (\$45 of each entry will go to the Jackpot for class winners/\$5 will be used for admin fees/promotion)
- A sliding scale will be used for the Jackpot based on entry numbers and winnings will be split 50/50 between buyer and seller
- The Claims Male classes will be judged by the Gathering Halter Judge
- Claim males can also be shown in their appropriate halter or Futurity class should the buyer choose with no late fee for up to 1 hour after the completion of the Claims Male classes
- Claims Male classes will be divided by age as follows
 - 5 to 12 Months
 - 12 to 24 Months
 - Above 24 Months
- Animals CAN BE claimed any time starting after the entry is live on the website and up to the class being placed by the judge
- No Substitutions will be allowed without prior approval from the Gathering Show and Sale Committee.
- This class is available to Proven Males, Young Males and Geldings
 - Proven Males: A proven male is a male that has settled a female or that has been tested fertile. Proven males will be considered to be fertile. There are NO expressed or implied warranties for proven males.
 - Young Males: Young males have been checked by a veterinarian and have been found to have anatomically normal reproductive organs. There are NO other expressed or implied warranties for young males.
 - Geldings: Geldings are eligible to participate and will be combined in the appropriate age class.
- Once males have been claimed, seller must notify a member of the Gathering Sale Committee, so website/promotion can be updated.
- DNA Testing Requirements: DNA testing is not mandatory.
- EXCEPT AS EXPRESSLY STATED ABOVE, SELLER MAKES NO WARRANTY OF MERCHANTABILITY AND WARRANTY OF FITNESS FOR ANY PARTICULAR PURPOSE, NOR DOES SELLER MAKE ANY WARRANTY EXPRESSED OR IMPLIED OF ANY NATURE WHATSOEVER WITH RESPECT TO THE ANIMALS IN THIS SALE. The foregoing is the full extent of the responsibility of the Seller, and by way of illustration and not limitation, in NO event shall the Seller be liable for incidental or consequential damages, or for any changes or expenses of any nature incurred without Seller's written permission.

- Transportation: The Buyer, at the Buyer's own expense, shall transport the llama unless other arrangements are made between buyer and seller. Any arrangement or disposition of the llama after purchase other than immediate removal must be made directly between the Buyer and Seller.
- Health Requirements: All Llamas entering the state of Iowa must be accompanied by a current 30 day health certificate.
- It is the Buyer's responsibility to examine llamas carefully and read these Terms and Conditions of the Sale.
