## Spring Showcase

C Bar C Expo Center – Cloverdale, IN

### Facility

- The 2026 Spring Showcase will be held at the C Bar C Expo Center which is located at 253 Stardust Rd. Cloverdale, IN 46120.
- Horse box stalls will be assigned to exhibitors. Stall Preference will be given to sponsors, sale animals and early entries. Transit animals must be stalled separate from animals exhibiting (See entry form for pricing) to ensure all exhibitors have closer access to the show arenas.
- Stalls floors are packed lime. As this is an equine facility, be prepared that there may be traces of shavings in your stall when you arrive.
- You may use stall mats or hay for bedding.
- Wash racks with heated water are available. Exhibitors are responsible for discarding fiber groomed off their animals in wash racks and aisles.
- The arenas and common area are made up of packed dirt. Walkways throughout the stall barn/vendor area are concrete.
- Temperature controlled restrooms are available throughout the building.
- A concession stand will be available at their regular posted times throughout the show.
- Trailer parking is available right outside of the stall barn.
- Campsites are available on the grounds. Please see "Lodging Information".

### Lodging Information

- Visit the Showcase website listed above for the list of host hotels/motels available at a reduced rate (while rooms last) and additional lodging details.
- Overnight camp sites, with electrical hookup, are available at an additional fee. Each site is available for \$45/evening. Please register on your show entry forms. There are showers also available in the show barn bathrooms.

#### Entry Information/ General Rules

- It is the exhibitor's responsibility to ensure they enter the correct class/classes in relation to their animal's sex, fiber type and age on the date of the show.
- All llamas entered in any of the classes must be fully registered or have a listing number recorded with the International Llama Registry when entries are submitted.
- Please do not enter your llamas in the bolded champion classes.
- All entries must be postmarked on or before March 6, 2026.
- Entries will not be accepted or processed without payment in full. No exceptions.
- A \$50 per animal fee will be assessed after March 6, 2026 on late entries, class changes or substitutions. These changes may not be reflected in the program.
- No class changes or substitutions will be allowed after March 13, 2026, except at the discretion of the judge.
- Non-breeder llamas must be recognized as such on their ILR Certificate or on a veterinarian certificate verifying non-breeder status.
- Llamas must be a minimum of 5 months old in order to exhibit.
- Nursing dams may not be accompanied into the ring by their cria.
- A llama ages to the next class on its birthday.
- Specific animals used to represent the sire or dam in production classes (Get of Sire / Produce of Dam) may be decided after halter classes have been placed. However, they must be listed with the show clerk **before** this class is held.
- Alpacas may compete in the performance classes/showmanship; however, we are not offering alpaca halter classes.
- It is the exhibitor's responsibility to have animal(s) at the show ring promptly for their class. If you need help, ask.
- Please reference the 2026 Guidelines regarding Performance Classes before entering your animal to insure you enter in the proper class/es. The 2026 Guidelines can be found on the ILR website.
- It is up to the Owner/Exhibitor to keep a record of their animal's performance placements and championships and to enter the animal correctly when entering ILR-SD Performance Classes.
- Exhibitors and their animals may NOT practice on any obstacles in the arena prior to the exhibitor's designated performance classes. Doing so may result in disqualification.
- For your convenience, all forms can be found on the website on the relevant pages OR on the "Printable Forms" page.

## Youth

- Minimum age for a handler in any class is seven years old. Exhibitors under 11 years of age cannot show intact males over the age of 18 months.
- The age division in which the youth will show will be determined by their age on January 1st of that year, however, if a youth reaches the age of 7 any time during the year, they will be eligible to show as of their birth date and when a senior youth reaches their 20<sup>th</sup> birthday, they are no longer eligible to show in the youth division at all.
- Effective January 1, 2018, the youth age divisions shall be as follows: Junior Youth – 7 thru 11 years, Intermediate Youth - 12 thru 14 years, Senior Youth - 15 thru 19 years of age.
- Youth may compete in Novice/Advanced Performance and Youth Performance, however, they must use a different llama.
- To qualify for Youth Performance Champion, the youth must show in Freestyle Obstacle, Companion PR and Trail Pack or Showmanship. They must use the same animal for the three performance classes. If showing in all four classes, the highest points in either Trail Pack or Showmanship will be used.
- Senior youth may complete their performance courses in conjunction with the Advanced exhibitors.
- Youth have the option to enter all or any combination of the following as long as they meet the requirements: **Youth Futurity, Youth Halter, Futurity, Halter**  
If participating in more than one, make sure appropriate classes are listed on the entry form and are paid.
- Youth Exhibitors do not need to be listed on the llama registration papers as an owner in the Youth halter classes (a lease is sufficient), but must be listed as owners to participate in the Youth Futurity classes.

## Health Requirements

- It is required that llamas or alpacas traveling into the state of Indiana be accompanied by a health certificate issued within 30 days. These forms are for your travel purposes only.
- All Showcase Sale Llamas are required to have a health certificate issued within 30 days and must be presented to the Showcase Sale Coordinators upon arrival.
- The Showcase Committee reserves the right to dismiss any animals from the premises who are displaying symptoms of infectious disease or communicable fungus.

#### Futurity Information

- Judging criteria will be based on conformation/movement, fiber quality, and overall appeal/marketability.
- The Futurity will be evaluated using a three-judge system.
- Guaranteed Futurity Payouts! Best of Show Female \$500 & Best of Show Male \$500, Class payouts will be based on the sliding scale in the 2026 Guidelines
- Entry fee is \$100/class
